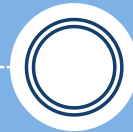

Flint Water Crisis

- Emergency State Funding
 - HB5220 \$28 million supplement
 - 4500 Flint toddlers and babies ages 0-3 are assessed for lead exposure
 - ✦ \$500,000 for school nurses
 - ✦ \$1 million for food banks and nutrition
 - ✦ \$1.75 million for assessments
 - \$300,000 Genesee County added nutritional support
 - Additional services:
 - ✦ National Guard providing water
 - ✦ Hiring additional nurses
 - ✦ Wrap-Around services (Early On and Special Education)
 - ✦ Water filters and filter replacements
 - ✦ Community education and support to child and adolescent health centers
 - ✦ Lab and testing costs, corrosion control and infrastructure study

Flint Water Crisis, Slide 2



- Since January 9, 2016:
 - 196,456 cases of water
 - 95,417 water filters
 - 30,255 water testing kits
- Water bottle recycling planning is underway
- Bathing:
 - It is safe to bathe in water from the Flint system
 - No scientific link connecting skin rashes to the change in water source
 - Children should be supervised at all times to avoid ingesting water

Michigan School for the Deaf



- In light of the Flint water crisis:
 - Bottled water has been in the school and the dormitory since August 2015
 - ✦ Used for drinking, cooking and brushing teeth
 - ✦ Drinking fountains were turned off
 - Water in the school tested negative for lead
 - Water in Stevens Hall (dorm) tested twice the acceptable level
 - All drinking fountain and sink faucets have been replaced in the dorm
 - Additional water testing scheduled for next week
 - Dept. of Public Health is conducting blood testing on site for students and their families as well as school staff

Michigan School for the Deaf, Slide 2



- Filling principal vacancy
 - Civil Service position defines requirements
 - Staff and deaf community stakeholder group to provide input regarding additional preferences
- Core planning team coming together to look at action steps in light of the structured dialogue that took place last fall
 - Friday, Feb. 19
 - At MSD
- Lt. Governor Brian Calley visited the school and spoke to the kids!

State Complaint System Improvement



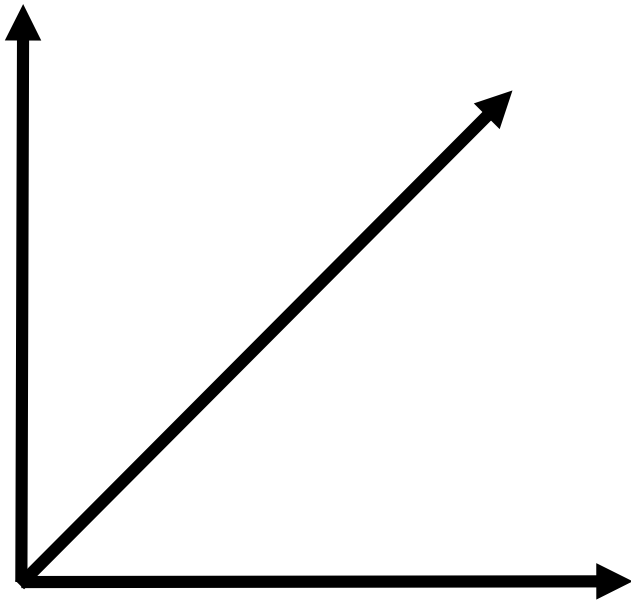
- January 25-26, 2016, Pingora Consultants met with 4 stakeholder groups and over 70 individuals. The groups providing input included:

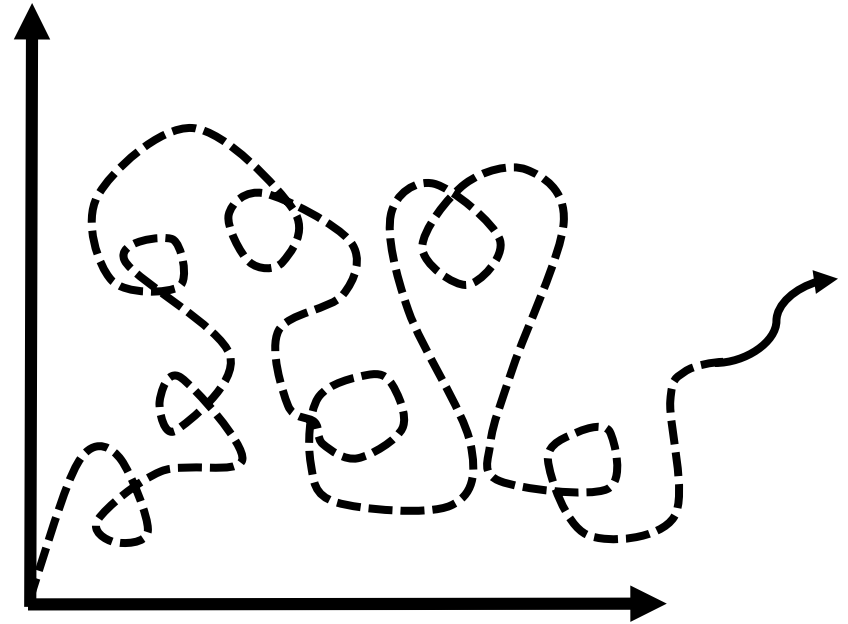

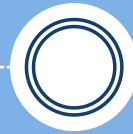
