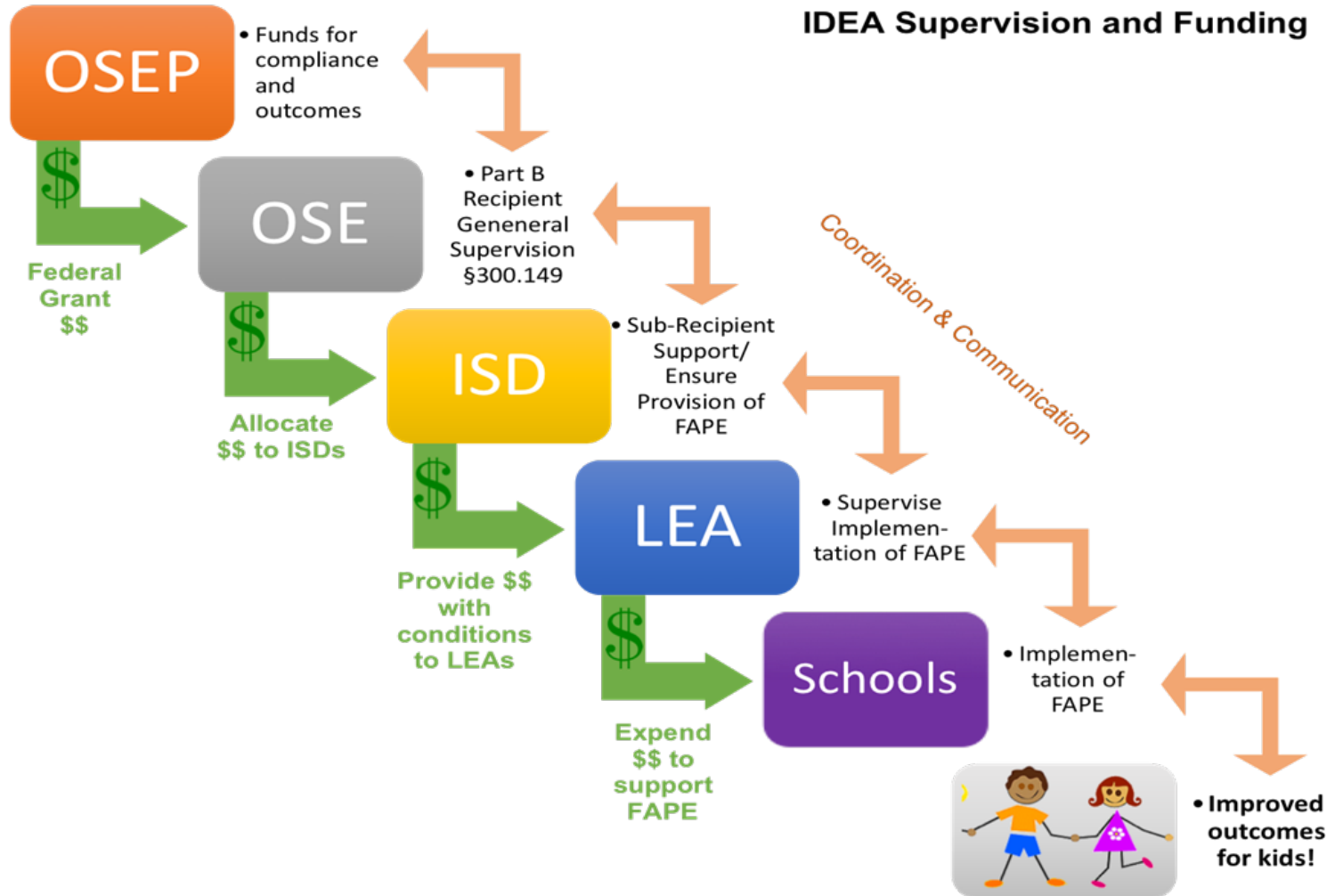

# Required State Accountability Structure

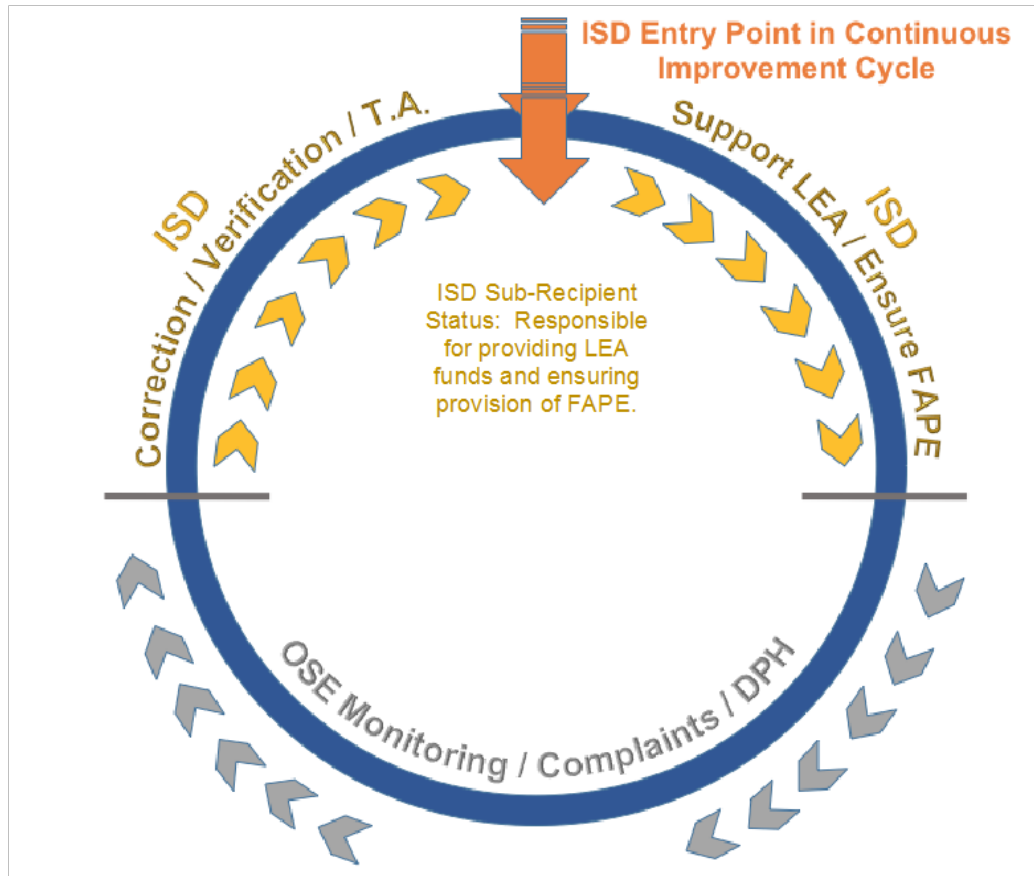

# Resulting Changes



- Redefine Supplemental EOSD Grant to ISDs
  - State level discretionary funds previously used to support monitoring
  - New language for data informed technical assistance
- Implication for change in accountability structures
  - Data reporting (SPP/APR)
  - Determinations
  - Monitoring
  - other

# IDEA Grant Funds



- Flow through applications
  - Due to the OSE by July 1, 2016
- CCRESA to secure contract language for the new OSE monitors
- ISD EOSD and Transition Coordination grants estimated allocations have gone out
  - Applications will go out approximately May 23, 2016
  - Applications will be due July 29, 2016

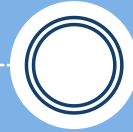
